DEPUTY REPORT

Deputy Brian Dowers gave the December 2017 report for Batavia Township. There were 21 adult arrests in the Township, 3 juvenile arrests, and 40 warrants served. Mr. Dowdney asked about the reporting/documentation system. Deputy Dowers replied the system is very thorough and complete, with checks and balances.

Deputy Dowers spoke about the Good Samaritan Law. It provides an opportunity for people who seek assistance in an overdose situation.

There was one burglary in December. There were 3 breaking and entering offenses.

PUBLIC PARTICIPATION

Mr. Parsons introduced Paul Braasch from Adams and Clermont Solid Waste District. Mr. Braasch spoke about the various options, containers including recycling containers, and all the bids received. He will work with Batavia Township and provide the specs of 5 other townships. When the service is bid out, it can be structured to suit the Township.

Public Hearing

Case B-04-17Z Stonelick-Olive Branch/Chintu Patel

Mr. Jonathan Wocher, zoning consultant, presented the plan and offered a summary. Mr. Patel spoke about the development plans. Sean House spoke and had a question about a traffic light.

Denise Kelley gave her year-end report, including the BZA and Zoning Commission. There were 136 single family home permits in 2017.

REPORTS OF THE SERVICE DIRECTOR

Mr. Embry gave his report.

The repairs on the VAC truck have been completed.

The surplus items were put on govdeals.com. All three items have been sold.

The transfer of roads included Chapel, Mt. Holly, and Benton Roads. The transfers have helped the Service Dept. be much more productive in those areas.

The damage repairs are being done on Lucy Run Cemetery.

The salt use so far this year has totaled 65 ton.

Mr. Embry will get a final price from Mr. Shinkle for the GraveYard Groomer.

The Union Cemetery Board met and posted 2018 dates for the clean-up days for the Township and Village workers.

REPORTS OF THE TOWNSHIP ADMINISTRATOR

Mr. Parsons spoke about the Aggregation certification steps.

Mr. Parsons was asked to apply to be a board member of the Port Authority Board. It is a tax exempt entity, but still pays property tax.

The CCTA dinner will be January 13th catered by 32-Q.

Mr. Parsons has not received an application yet for the Salute to Leaders and asked the Trustees to consider applicants and let Mr. Parsons know.

Mr. Parsons spoke about the CDBG grant application.
