The salt use to date for this year is 538 ton used in 16 rounds.

The surplus equipment sold for \$2,750. As discussed, the money will be used to work on the dugouts.

There have been some wash out issues on Snyder Road. Mr. Embry will be meeting with FIMA.

There was an incident at 4311 Milhaven Drive. A gas valve was hit, which was buried and hidden in brush.

Mr. Embry spoke with Barrett Paving and they will start working on the Wolfe Creek paving project in May.

The new stop signs on State Route 132 and Chapel appear to be effective.

Mr. Embry attended a class on micro-surfacing. It is 35-45% cheaper than asphalt. The application can be used on some roads, but not on all.
